Consumer Credit Market Report

Executive Summary

This report and its appendix represent the analysis of quarterly data of the South African consumer credit market in terms of the National Credit Act which came into effect in June 2006.

The total value of new credit granted increased from R138.81 billion to R146.87 billion for the quarter ended June 2021, an increase of 5.81% when compared to the previous quarter and an increase of 168.59% year-on-year. The number of applications for credit increased from 10.00 million to 11.30 million in June 2021, representing an increase of 13.06% for the quarter. The rejection rate for applications was 63.61%.

The Banks' share of total credit granted was R122.14 billion (83.16%), Retailers R4.85 billion (3.30%), Non- Bank financiers R9.82 billion (6.68%) and "Other credit providers" R10.06 billion (6.85%). Other credit providers consists primarily of pension backed lenders, developmental lenders, micro-loan lenders, agricultural lenders, insurers, non-bank mortgage lenders and securitised debt.

The total outstanding gross debtors book of consumer credit for the quarter ended June 2021 was R2.05 trillion, representing a quarter-on-quarter increase of 0.95%. The number of accounts increased by 3.08% for the quarter ended June 2021. Mortgages accounted for R1.06 trillion (51.63%); "Secured credit agreements" for R459.56 billion (22.37%); Credit facilities for R265.94 billion (12.94%); Unsecured credit for R210.18 billion (10.23%); Developmental credit for R56.19 billion (2.73%) and Short-term credit for R1.95 billion (0.09%) of the total gross debtors book.

The following were some of the most significant trends observed for the quarter ended June 2021:

- The value of mortgages granted increased by 4.27% quarter-on-quarter from R54.27 billion to R56.59 billion;
- Secured credit granted increased from R40.95 billion for March 2021 to R43.18 billion for June 2021 (a quarter-on-quarter increase of 5.45%);

- Unsecured credit agreements increased from R20.13 billion to R22.45 billion for June 2021 (a quarter-on-quarter increase of 11.51%);
- Credit facilities which consist mainly of credit cards, store cards and bank overdrafts increased from R19.66 billion to R20.84 billion for June 2021 (a quarter-on-quarter increase of 6.02%);
- Short-term credit showed a quarter-on-quarter increase of 12.20% from R1.97 billion to R2.21 billion;
- Developmental credit showed a quarter-on-quarter decrease of 12.25% from R1.83 billion to R1.61 billion.

Introduction

The Consumer Credit Market Report is issued by the National Credit Regulator. It is based upon returns which credit providers are required to submit in terms of the National Credit Act (NCA). The statistics presented in this report cover the quarters up to 30 June 2021 (2021-Q2).

The reporting requirements of the NCA differentiate between small credit providers, defined as credit providers for whom annual disbursements are less than R15 million, and larger credit providers, defined as credit providers for whom annual disbursement is more than R15 million. Credit providers with annual disbursements of more than R15 million are required to submit quarterly returns. Credit providers with annual disbursements of less than R15 million are only required to submit annual returns. The statistics included in the report follow the scope and definitions in the NCA. The report thus reflects all consumer credit, as well as agreements with juristic persons with a turnover or net assets of less than R1 million. It excludes all other juristic persons. The reporting quarters (Q) in the CCMR are as explained in the table below:

Quarters	Reporting period
Quarter 1 (Q1)	1 January — 31 March
Quarter 2 (Q2)	1 April – 30 June
Quarter 3 (Q3)	1 July – 30 September
Quarter 4 (Q4)	1 October – 31 December

"Secured credit" in this report refers to transactions which were classified as "Other credit agreements" in the previous Consumer Credit Market Reports. This credit type includes transactions that do not fall within any of the other categories in the NCA. It includes a range of secured credit agreements, such as pension-backed loans, Insurance-backed loans, retail furniture accounts and motor vehicle accounts and consists of all credit that is secured, other than mortgages and credit facilities. Detailed tables on the data shown in this report can be found in the Appendix.

Abbreviations - "year-on-year (y-o-y)" as used in this report refers to a comparison of the quarter ended June 2020 to the quarter ended June 2021 and "quarter-on-quarter (q-o-q)" refers to a comparison of the quarter ended March 2021 to the quarter ended June 2021. The totals reported in the "Credit granted" sections do not add up to the totals reported in the "Level of income" sections due to loans granted to juristic persons where the level of income is not reported by credit providers. This applies to all the credit types reflected in this report.

1. Market overview

The value of the outstanding gross debtors book as depicted in Figure 1.1 increased by R19.33 billion (0.95%) for the quarter ended June 2021. The value of credit granted to consumers increased by R8.07 billion (5.81%) from R138.81 billion to R146.87 billion for the quarter ended June 2021.

Figure 1.1 Total credit granted and gross debtors book June 2021



1.1 Credit granted

The value of consumer credit granted for the quarter ended June 2021 showed an increase of R8.07 billion (5.81%) when compared to the quarter ended March 2021 as depicted in Table 1.1. On a y-o-y basis the value of credit granted increased by R92.19 billion (168.59%).

The total number of credit agreements entered into was 3.50 million for the quarter ended June 2021. This was an increase of 9.63% when compared to the previous quarter as indicated in Table 1.2. On a y-o-y basis the total number of credit agreements entered into increased by 70.79%.

Banks accounted for 83.16% of the total value of credit granted for the quarter ended June 2021 as indicated in Table 1.3. The balance was shared by non-bank vehicle financiers (6.68%), retailers (3.30%) and other credit providers (6.85%).

The rejection rate increased from 62.47% for the quarter ended March 2021 to 63.61% for the quarter ended June 2021. The number of applications received increased by 13.06% and number of applications rejected increased by 15.11% for the quarter ended June 2021.




Figure 1.2: Credit granted – percentage distribution

The Unsecured credit share of total credit granted increased from R20.13 billion for the quarter ended March 2021 to R22.45 billion for the quarter ended June 2021 as indicated in Table 1.5 and Figure 1.2. Mortgages' share of total credit granted increased from R54.27 billion for the quarter ended March 2021 to R56.59 billion for the quarter ended June 2021.

There was a q-o-q increase of R19.33 billion (0.95%) in the value of gross debtors book for the period ended June 2021 as indicated in Table 1.6. The corresponding y-o-y growth was R91.04 billion (4.64%). The Mortgage credit book increased by R18.16 billion (1.74%) q-o-q and by R76.48 billion (7.77%) on a y-o-y basis. The Secured book increased by R3.12 billion (0.68%) q-o-q and by R16.06 billion (3.62%) on a y-o-y basis.


There was a q-o-q (0.95%) and y-o-y (4.64%) increase in the gross debtors book per industry type as indicated in Table 1.7.

The number of accounts that make up the debtors book increased by 3.08% from 35.93 million to 37.04 million for the quarter ended June 2021. The total number of accounts decreased by 3.47% on a y-o-y basis. Credit facilities had the biggest share of 68.32% of the total number of accounts for the quarter ended June 2021 as indicated in Table 1.8.





A significant portion of credit granted went to consumers in the Gauteng province at R62.84 billion (42.79%). The Western Cape and KwaZulu-Natal accounted for R27.04 billion (18.41%) and R20.27 billion (13.80%) respectively. The remaining provinces constituted R36.73 billion (25.01%) as illustrated in Figure 1.3.

The rand value of mortgage agreements granted increased by 4.27% for the quarter ended June 2021 as indicated in Table 2.1. The majority (87.48%) of mortgage agreements granted during the June 2021 quarter were in excess of R700K. Total mortgages granted on a y-o-y basis increased by 335.77%.

The number of mortgage agreements entered into increased by 1.07% for the quarter ended June 2021 as indicated in Table 2.2. The majority (65.46%) of mortgages were granted in favour of larger sized credit agreements (\geq R700k). On a y-o-y basis mortgage agreements increased by 273.69%.



2.3 Gross debtors book - mortgages

The rand value of the gross debtors book for mortgages showed an increase of R18.16 billion (1.74%) on a q-o-q and of R76.48 billion (7.77%) on a y-o-y basis. The number of accounts increased by 1.54% q-o-q and by 0.95% on a y-o-y basis as indicated in Table 2.5.

2.4 Age analysis of gross debtors book - mortgages

The percentage (rand value) of the gross debtors book for mortgages reported as "current" decreased from 91.69% for March 2021 to 90.88% for June 2021. The percentage (number) of accounts reported as "current" decreased from 91.53% to 90.68% for the same period as illustrated in Figure 2.1

3. Secured credit

3.1 Secured credit granted

In terms of the Regulations, the category "Other credit agreements" refers to secured credit agreements but excludes mortgages and credit facilities.

As indicated in Table 3.1 the value of secured credit granted increased by R2.23 billion (5.45%) on a q-o-q basis. Vehicles as a form of security continued to dominate secured credit at R39.23 billion (90.85%).

There was an increase in the percentage share of the numbers of secured credit agreements for individuals with a gross monthly income of "Up to R10K" from 29.74% to 31.44% for the quarter ended June 2021 as indicated in Table 3.3. The percentage share of the number of secured credit agreements entered into with individuals with a gross monthly income of "Greater than R15K" decreased from 61.03% to 60.15% for the quarter ended June 2021.



The rand value of the gross debtors book for secured credit showed an increase of R3.12 billion (0.68%) for the quarter ended June 2021 and of R16.06 billion (3.62%) on a y-o-y basis. The number of accounts increased by 8.18% q-o-q and by 5.60% on a y-o-y basis as indicated in Table 3.5.

3.4 Age analysis of gross debtors book – secured credit

The percentage (rand value) of the gross debtors book for secured credit reported as "current" increased from 87.26% for the quarter ended March 2021 to 87.53% for the quarter ended June 2021. The percentage (number) of accounts reported as "current" decreased from 73.10% to 67.47% for the same period as illustrated in Figure 3.1.

4. Credit facilities

4.1 Credit facilities granted









Gross debtors book	The outstanding balances as at the end of the period including fees and interest that have been earned and capitalized to the debtors book.
Mortgage agreements	An agreement that is secured by a pledge of immovable property.
